On plastic material and articles intended to come into contact with food for the below mentioned test conditions.

Test conditions: The migration was performed in accordance with relevant parts of EN 1186 as EN 1186-2, EN 1186-3, EN 1186-14, EN13130, EN 13130 and EPA 3052m.

Principle of migration test that has been performed:

Olive oil	the sample was exposed for by total immersion.
3% acetic and 10% ethanol	the sample was exposed for 2 hours at 70 °C.
Isooctane	the sample was exposed for 30 minutes at 40 °C.

Specific migration: An aliquot of the food simulant is analyzed for specific compound. The test was performed with triplicates.

The results for specific migration are below the specific migration limit. The threshold value for overall migration is 10mg/dm².


